OVERVIEW

In the event that an i-PRO Americas Inc product has a defect in material or workmanship, i-PRO will exchange or repair the non-functioning unit with a new or functioning refurbished product, free of charge, provided the failure occurs within the standard or extended warranty period (determined from the original date of purchase on an invoice or purchase receipt) If no proof-of-purchase is available, the date of manufacture will be determined from the model and serial number of the unit).

i-PRO Accidental Damage Warranty

Any body-worn camera unit for which the i-PRO "Accidental Damage" warranty has been purchased will receive additional coverage for any failure that occurs due to accidental damage.

All other terms and conditions of the standard warranty apply and this additional coverage will exist for the duration of the standard warranty period of the unit. If an extended Accidental Damage warranty program is purchased, coverage is applied to the end of the last year of existing coverage purchased.

This warranty does not cover failures or defects that are caused by fire, intentional acts, loss, theft, improper maintenance, modification or service by anyone other than the i-PRO National Service Center or an i-PRO Authorized Service Provider, or damage that is attributable to acts of God. Cosmetic damage that does not affect functionality is not covered.

Cosmetic damage on products with hardware failures will be repaired or replaced in accordance with the warranty terms. This warranty is extended solely to the original purchaser on the unit serial number for which it was purchased. Complete unit replacement fulfills the full obligation and is at the discretion of i-PRO and is limited to once during the coverage term.
