


Confirm the AC mains plug fitted and follow the instructions below. Illustrations may differ from actual AC mains plug.

Introduction

Preface

The network disk recorders WJ-NX400K and WJ-NX400K/G (hereinafter, recorders) equipped H.265 CODEC and are designed for use within a H.265 surveillance system, and record images/audio from up to 64 network cameras (hereinafter, cameras) on the hard disk drives (HDDs). Number of cameras to be used in the system (64 cameras in basic system) can be increased to 96 and 128 (maximum) by purchasing the Additional Camera Kit (WJ-NXE40, WJ-NXE40W).


The optional HDDs encased in the provided HDD canisters (hereinafter referred as HDD units) can easily be installed/removed in/from this recorder.

This recorder can connect the extension unit WJ-HXE400 (option) up to five and support up to 54 HDDs.

This recorder supports connection with a monitor equipped with the HDMI (High-Definition Multimedia Interface) connector. Connection using an HDMI cable (optional) offers display of playback/live images with superior quality.

It is possible to display images from multiple cameras, switch those images and perform basic operation of the camera.



Major operating controls and their functions

Front view



1 Error indicator [ERROR]

Blinks when an error that can become a problem for the recorder to run the system occurs.

Blinks red: System error (Network link error, HDD error, Recording error, etc.)

Blinks orange: Thermal error, cooling fan malfunction, etc. Shows a solid light when automatically reset from an error status.

2 Alarm indicator [ALARM]

Blinks when an alarm occurs, and lights when the alarm output stops. This indicator will go off when the [Reset] button (© Operating Instructions (PDF)) is clicked.

3 LCD

Indicates the day and time, the status of the recorder (error status, etc.), or the name of the functions available using the buttons on the front panel of the recorder. The recorder requires a main monitor or a PC for settings. You cannot setup the settings using the LCD of the recorder only.

4 Buzzer stop button [BUZZER STOP]

Press this button to stop the buzzer that started sounding at an alarm/error occurrence. Refer to the Operating Instructions (PDF) for further information about alarms and errors.

5 HDD access indicator (1~9)

It transmits the HDD status indicator and the HDD access indicator installed in the front cover.

HDD status indicator (left side)

Indicates the operational status of the respective hard disk drive. (FSP Page 17)

HDD access indicator (right side)

Indicates the status (access/failure) of the respective hard disk drive. (** Page 17)

Basically, each indicator will indicate the status of the respective HDD units (HDD unit 1 to 9), but each indicator will be the same when the system error occurs.



3 HDD access/failure indicator (A/F)


6 Restart switch

7 HDD unit holding bracket fixing thread hole

1 Alarm/Control connector [ALARM/CONTROL]

This connector is used when connecting with an external device such as a sensor or anti-theft door switch that output alarm signals, or when connecting an alarm device such as a buzzer or a lamp to the external equipment. The two provided terminal plug (12 pin) can be mounted.

2 Alarm In connector [ALARM IN]














After inserting the provided key into the key hole on the front cover, push and turn it to the right to open the front cover.

Insert the HDD units into the HDD slots in order starting from HDD1.

 - Insert the HDD unit carefully without knocking it against anything (and without knocking against HDD units which are already inserted).





Remove the HDD unit.

- ① Pull the lever up while holding down the removal knob on the HDD unit.
- ② Pull the HDD unit out from the HDD slot. Pull the HDD unit out carefully so as not to drop it and handle it gently so as not to give it a shock or vibration.

Important:


 When removing the HDD unit, be careful not to pinch your fingers with the lever.



Step 3

Close the front cover and lock it by pushing and turning the key to the left.

Keep the key in a safe place.



Remove the extension unit from recorder

When removing the extension unit, it is necessary to perform the removal process in advance. When replacing the extension unit, it is necessary to perform the removal process/the link process.

Important:

- · Consult the dealer for the removal process/removal and the link process/installation of the extension unit.
- Once the installation process is completed, the data in the HDD unit of the extension unit is deleted.
