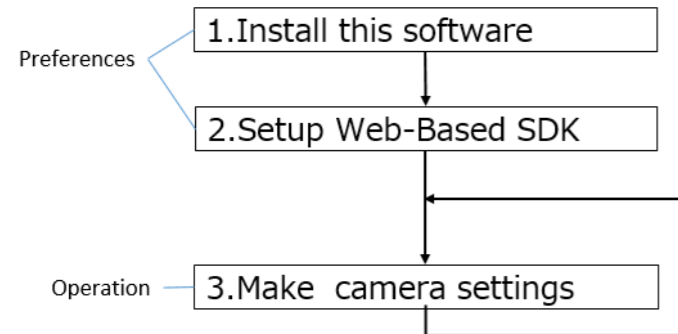


# i-PRO Settings Plug-in for Genetec

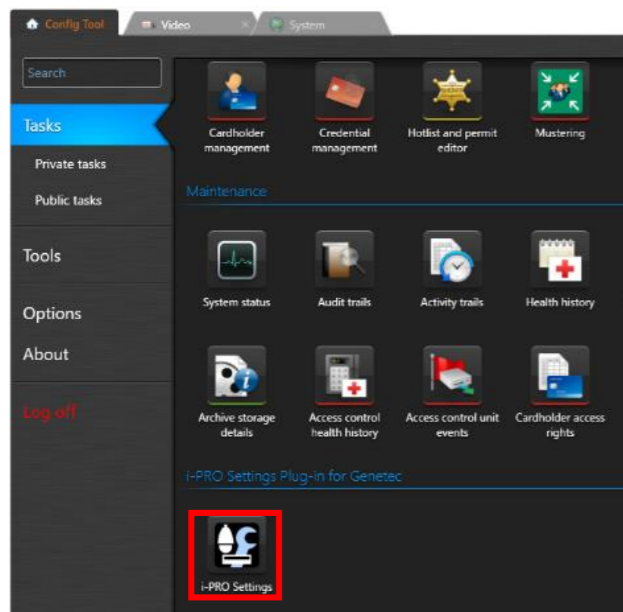
## Operation Overview



### 1. Install this software (\*1)

1.1 Extract the "iCTPluginSetup" zip package file.

1.2 Double-click the "iCTPluginSetup.exe" from extracted zip file to register the "i-PRO Settings" on "Config Tool" window.

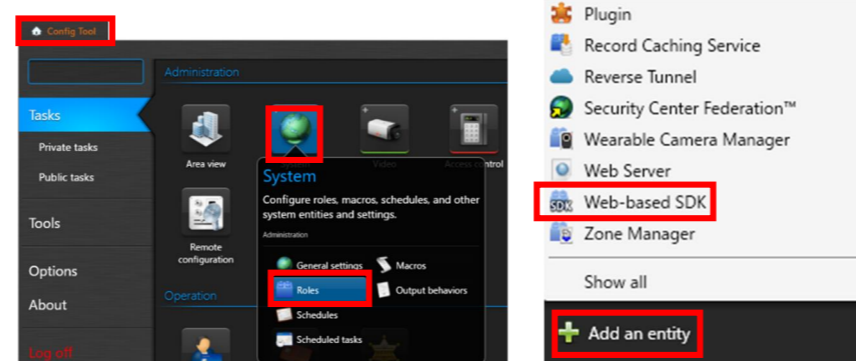


(\*1) For uninstallation, close "Config Tool" and "Security Desk" prior to uninstall this software.

### 2. Setup Web-based SDK

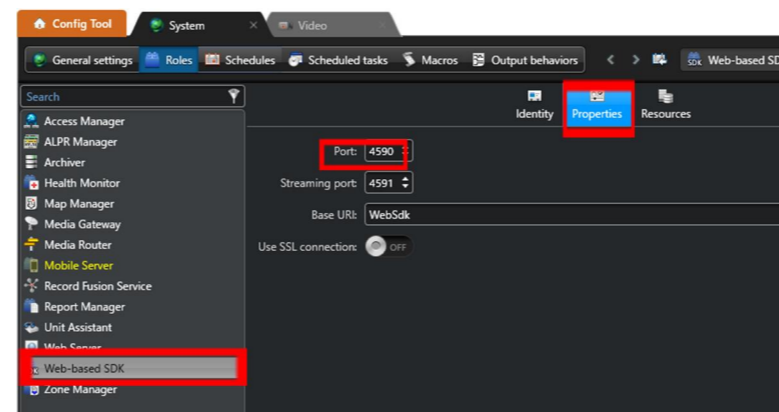
#### 2.1 Activate the Web-based SDK

Click [Config Tool] - [System] - [Roles] button.  
Click [Add an entity] button at the bottom left of the screen and select the [Web-based SDK].



#### 2.2 Confirm the Port Number

Click [Properties] in [Web-based SDK]. Confirm the Port Number. Default Port number is 4590.  
(This port number is used in Step 3.1.)



### 3. Make camera settings

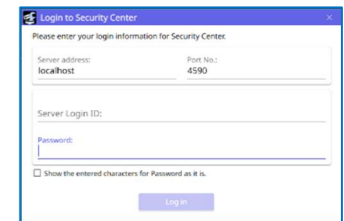
#### 3.1 Start up this software and log in Security center

To click the "i-PRO Settings" icon on "Config Tool" panel.



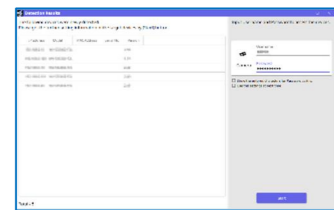
Enter the Log in information of Security Center.

- Credentials (User ID & Password)



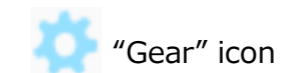
#### 3.2 Get camera list

To connect to the camera, you need to enter username and password of the cameras.

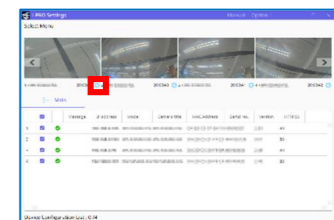


#### 3.3 Make camera and/or Extension Software (\*2) settings

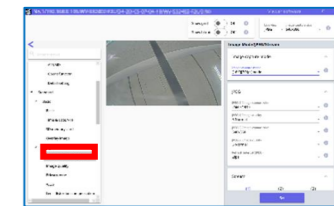
Click the "Gear" icon at the bottom of the thumbnail of target camera to start the settings.

(\*2) Before using this function, it is necessary to install the Extension Software. It can be installed on multiple cameras at the same time by using the "i-PRO Configuration Tool".

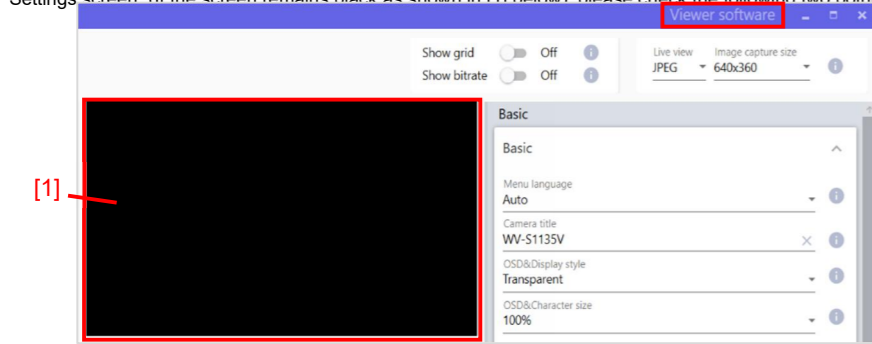

In case of Stream video (1)-(4) is not displayed on the Camera Advanced Settings screen or Expansion Software Settings screen. (If the screen remains black as shown in [1] below), please check the following two points.

Check that "Network Camera View 4S" (plug-in software) is shown on the control panel "Programs and Features". If it is not shown, click "Viewer Software" in the upper right corner [2] of the Camera Advanced Settings screen to install the plug-in software.

#### 2.Windows Defender Firewall settings

If the video display may be restricted by the Windows firewall function, please follow the steps below.

i-PRO Settings Plug-in for Genetec is the software that is designed to configure the settings of network cameras using a PC via a network. This software is assumed to be used by system design and network management experts. Descriptions are based on the assumption that Microsoft® Windows® 10 Pro. In addition, the screens shown in this manual may include the previous versions within the scope of the explanation.
